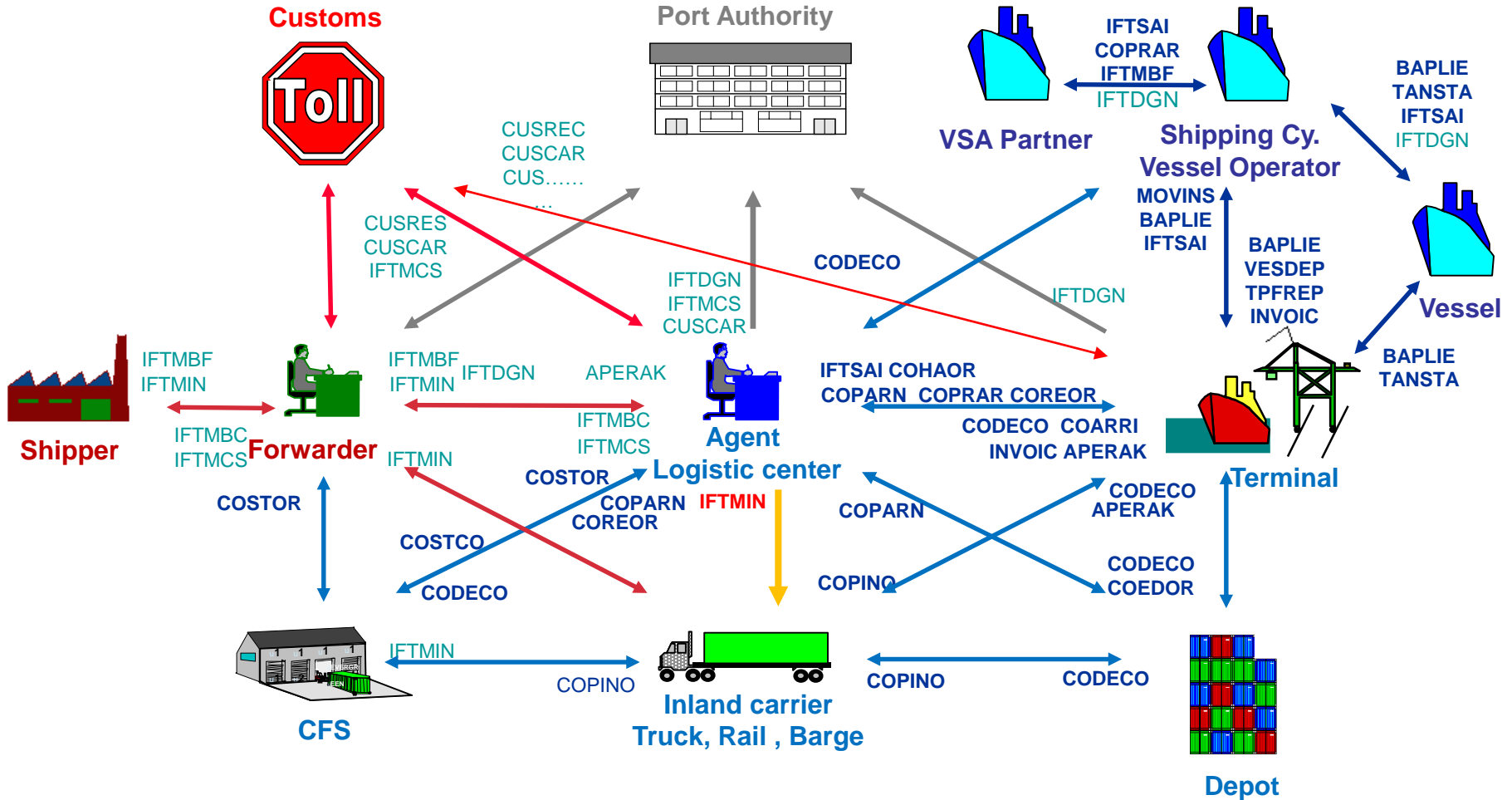

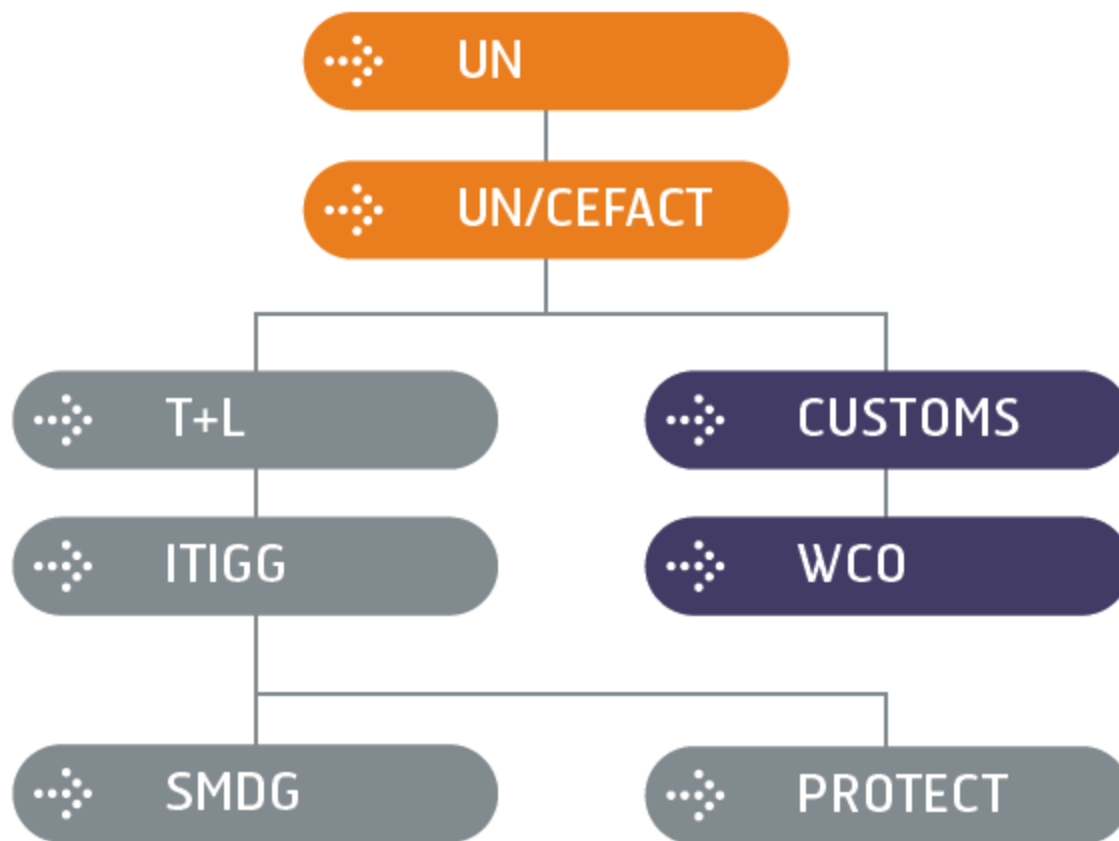

UN Subgroups



UN/CEFACT

- ◆ UN/CEFACT is an official intergovernmental organisation within the UN.
- ◆ The purpose of the UN/CEFACT Applied Technologies Group (ATG) is to **create and maintain the United Nations trade, business and administration document structures** that are deployed by a specific technology or standard, such as UN/EDIFACT, UN Layout Key, UN e-docs or XML.
- ◆ A huge number of experts in different work areas of projects from all over the world have been participating in the work for more than 25 years.

UN Subgroups



ITIGG

- ◆ ITIGG is a subgroup of T+L, the UN/EDIFACT Message Development Group for Transport.
- ◆ ITIGG develops **recommendations** which provide software developers with a series of simple, straightforward **tools to assist in designing implementation guidelines** (MIG) for applications which can be used for trading electronically throughout the world, and to clarify the intentions of the designers of key UN/EDIFACT messages.

UN Subgroups



■ PROTECT

- ◆ In support of the electronic **reporting required by authorities** for vessels entering or leaving a port or port area, the PROTECT Group has established a harmonised, globally recognised EDI standard.
- ◆ The group's main focus is the messages relating to **laws and regulations relating to Port Authority** matters, such as **vessel notification, dangerous cargo** and **waste disposal**.

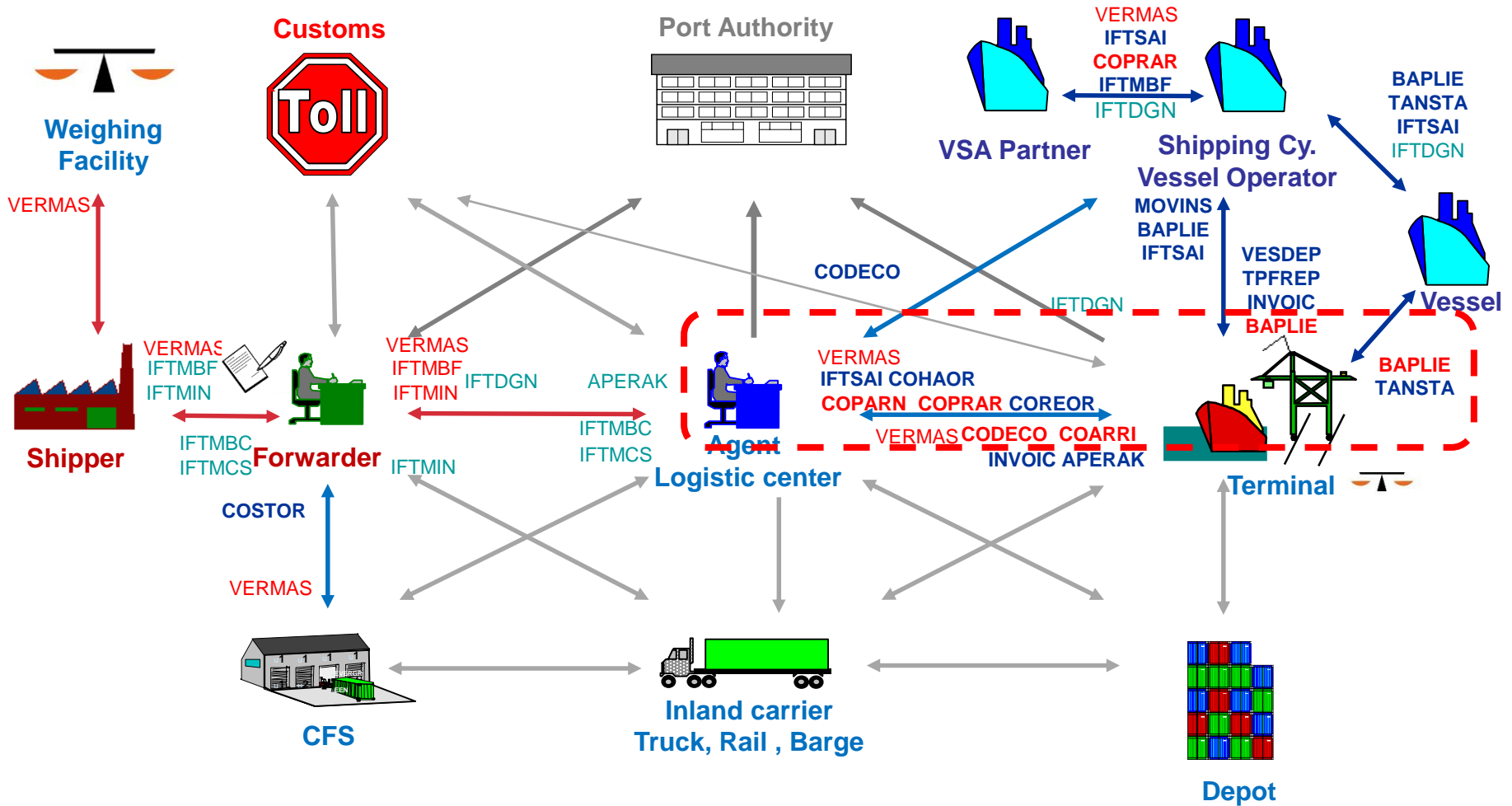

- 7.3 In its simplest form the information flow regarding the provision of a verified gross mass may look something like the following:-

SHIPPER → SHIPPING LINE → TERMINAL OPERATOR



Proposed solution



- ❖ **Narrow timeline – July 2016**
- ❖ **Only one scope – implement VGM**
- ❖ **Limit changes to messages and systems**
- ❖ **If possible - no new mapping**
- ❖ **Known techniques and recommendations**
- ❖ **Recognizable for current users**

Proposed solution



- ❏ **Keep current structure D.00B**
- ❏ **Have new codes and qualifiers approved in newest directory (D.15B)**
- ❏ **Propose accepted codes in upgraded implementation guide in older version**

📦 Preferred - certified

📦 **D.95B - ITIG14 /ITIG12** → **SMDG16**

Evaluation



- ◆ **SMDG20 –**
 - ◆ Better manuals
 - ◆ Structure better adapted for current practices
- ◆ **More and better DGS – dangerous goods**
 - ◆ COPRAR - 9 → 99 → legal requirement
 - ◆ TLQ – limited quantity
- ◆ **Code lists official**
- ◆ **Clarification (by samples – cfr. BAPLIE)**

Issues?



- ◆ **GID group?**
- ◆ **Change Management D.95B → D.00B**
 - ◆ **Removed**
 - ◆ ~~2~~ ***Addition***
 - ◆ ~~3~~ ***Deletion***
 - ◆ ~~4~~ ***Change***
 - ◆ **Only**
 - ◆ **1 Cancellation**
 - ◆ **5 Replace**
 - ◆ **9 Original**

Enhancements also D.95B



- ◆ **95% of current messages**
- ◆ **Single scope → only VGM**
- ◆ **Same method for D.95B as D.00B**

- ◆ **D.95B - ITIG14/ITIG12 → SMDG16**

- ❖ **Since february 2016 with new off. codes**
- ❖ **Carrier questionnaires align with guides**
- ❖ **Sample messages also OK**
- ❖ **Testing is going on**
